Support of a new viewing site suggested by TCI from The Street near the school entrance.

Suggest new viewing sites from Saxlingham Green and Fritton Common, both being conservation areas.

Bats.

The effect of the large size of the site.

Cumulative impact

Impact of access roads / infrastructure / anemometry mast/ancillary buildings on the nature of the site.
