Minutes of the previous meeting

The minutes of the meeting on 10th September 2013 were approved and signed.

Public Participation

Wind Turbines

The plans were made available for the public viewing.

It was noted that the concreted area for the old turbine 2 was still in place on the plan despite the description indicating that it is not. It was asked if this was a mistake or does it possibly indicate a phase two is envisaged.

Mrs Franks indicated that it was a reasonable expectation that SNC ought to have made notes of any calls between SNC and the applicant, should these not be published on the SNC website as they are important to the matter.

Mrs Taylor felt this was only phase one of the development if the application was allowed.

Concern was also expressed about the lower power output and lower carbon saving.

The clerk and Mr Hook had sent a letter requesting the support of Richard Bacon MP, County Councillor Alison Thomas, District Councillors Michael Windridge, Murray Gray and Florence Ellis and surrounding parish councils. **ACTION**

The clerk reminded the meeting that Richard Bacon MP was holding surgery in Long Stratton on 23 September at Barclays Bank and parishioners were encouraged to attend to let him know their views.

The clerk reported that he had received copies of emails to SNC planning officer Gary Hancox from County Councillor Thomas, District Councillors Windridge and Ellis all recommending that extra time be granted. The clerk had called Mr Hancox today and been informed that there would be an extension granted but it may not be for the 10 weeks requested. Mr Hancox had yet to speak to Mrs Mellors of SNC and the applicant.

Mrs Franks asked the parish council to call a parish meeting to consider holding a parish poll. Mr Hook asked parishioners present if they would like the parish council to consider calling a parish meeting re the parish poll 19 parishioners voted for this, 1 against and 2 abstained.

Mr Pointer proposed, Mr Delf seconded and it was unanimously agreed that the parish council submit and interim decision subject to the result of the next parish poll.

Mr Workman proposed, Mr Pointer seconded and it was unanimously agreed that the application be recommended for refusal.

Mr Hook proposed, Mr workman seconded and it was unanimously agreed that a full response will be submitted post the parish poll and a brief response be submitted as the interim response. **IN/DH**

Mr Workman proposed, Mr Ashford seconded and it was unanimously agreed that a parish meeting be called to consider this matter on 26 September at 7.30pm in the Mill Centre with a view to the poll being taken on the 21 or 28 October 2013 at the Mill Centre. The clerk to book the hall and reserve the October dates accordingly. Mr Hook to liaise with SNC re the poll. **IN

Mr Hook proposed, Mr Ashford seconded and it was unanimously agreed that the modifications to static and animated photomontages be commissioned at a cost of £420+VAT. The clerk to instruct the Mr Blackledge accordingly. **IN**

Mr Buck had emailed Mr Hook confirming that any outdoor lighting on the new sheds would be motion activated with halogen type bulbs (not dusk to dawn sodium) and in addition that the two new poultry buildings were a replacement for the consented free range unit and not in addition to it. – Recommended approval. **IN**
