County and District Councillor Report

County & District Councillor Alison Thomas provided a verbal report the main points of which were:

District Council Matters

The district ward boundary review has been carried out to equalise the number of parishioners represented by a councillor.

In parish ward boundary review it is proposed Hempnall ward will no longer be linked to Woodton and Bedingham but will be linked to Topcroft and Tasburgh. Mrs Thomas encouraged the parish to make comment in the consultation period.

There is still a call for sites for the next GNLP despite the deadline for submissions having passed. Mr Hook asked Mrs Thomas to check if sites for the GNLP were still being accepted as this was not his understanding. Mrs Thomas agreed to do so.

County Council Matters

Mrs Thomas reported that the County Council had been through a difficult year, particularly regarding issues around money.

More children are being educated in good or outstanding schools in Norfolk and the county had improved in the national exam rankings.

Adult social care – The "in good company" campaign – Mrs Thomas encouraged individuals to pledge to do a small regular gesture to help somebody.

The "Better Broadband" project continues with the aim of 95% of Norfolk to be covered by 2020.

The Northern Distributor Road ("NDR") is progressing with 9km of carriageway ready for tarmacking.

Mill Fields #2 site

Mr Hook asked if Mill Fields #2 site could be used as a social housing site as the parish council requested. Mrs Thomas agreed to make enquiries.
