The Hempnall Trust is an interesting and long standing village charity. It both provides individual grants for any village resident experiencing ‘need, hardship or distress’ and also runs the Mill Centre on Mill Road. The Centre is used as a social centre for older residents, providing lunches and activities and a general cafe is run monthly there too.

Trustees meet monthly and contribute to the general work of the Trust. They also serve on the Property Charity, which meets less frequently.

The Hempnall Trust is concerned to make sure that the Trustee body reflects a wide range of ages and village interests.

The Secretary of State, Eric Pickles, has announced his decision regarding the wind turbine planning application for Hempnall. The application has been refused although TCI have 6 weeks from 28/10/14 to apply for a judicial review. Many parishioners have made great sacrifices in both time and money in order to act on villagers wishes as demonstrated in the parish poll, to oppose the application and councillors thank those involved. Hopefully resources can now be directed towards positive facilities for the village – see below.
