### ***Wind Turbines Judicial Review Update***

This is scheduled to be heard on 17 March 2015. The hearing will be held at the Royal Courts of Justice in London. Members of the public can attend and are perfectly welcome to go, however we are advised that the court will not be swayed by a strong show of support for either view.

The judge may announce his/her decision on the day, but is more likely to reserve judgment to be handed down at a later time, normally within a few weeks. That judgment will be open to appeal by the losing side to the Court of Appeal if they can persuade either the judge or the Court of Appeal to grant permission to appeal.



### ***Morningthorpe Recycling Centre - Cut in Opening Hours***



In April 2015 six recycling centres in South Norfolk are due to change to part-time hours to make a cost savings for Norfolk County Council. It is proposed that these sites operate on Thursday to Sunday inclusive, Morningthorpe is one of these sites. Thus the site will be closed Monday to Wednesday each week.
