## ***Greater Norwich Local Plan (GNLP)- Hempnall***

We have been notified of 4 further sites submitted for consideration for residential development in Hempnall. All of these sites are outside the Development Boundary of the village.

- 1) GNLP1015 1.6ha – Land adjacent to primary school - 19 dwellings and extension to primary school car park
- 2) GNLP 1016 1.3ha – Land at Bussey's Loke - 50 dwellings (the meadow next to the churchyard)
- 3) GNLP 1017 0.9ha – Land at Broaden Lane - 20-25 dwellings (opposite Old Market Way)
- 4) GNLP 1018 3ha – Land south of Millfields - 75 dwellings

The Parish Council does not support the development of any sites outside the current development boundary. Public consultation on the emerging GNLP is scheduled to commence in January and will be discussed by the Parish Council at its meeting on January 16<sup>th</sup>.
